Board had earlier notified the tariff of Internet Bandwidth through its letters under reference above. The Internet Bandwidth is purchased centrally from RailTel Corporation of Indian Limited and is paid centrally by Northern Railways chargeable to 'Revenue'. This amount is re-appropriated equally between all the sixteen zonal Railways and Northern Railway is accordingly provided credit of take amount by all other zonal Railways.

2. As the purchase price of IBW for RailTel has undergone revision since last tariff notification by Board, the following tariff and their applicable period is notified.


